**AN ORDINANCE AMENDING ORDINANCE NO. 22-690, ENTITLED "AN ORDINANCE AMENDING ARTICLES C AND F OF ORDINANCE NO. 15-438, OTHERWISE KNOWN AS THE REVENUE CODE OF ISABELA CITY, ESTABLISHING NEW ECONOMIC ENTERPRISES AND PRESCRIBING ITS FEES AND CHARGES THEREON," SPECIFICALLY REGARDING THE FEES AND CHARGES FOR THE LEASE OF OFFICE SPACES IN ALL CITY GOVERNMENT OWNED BUILDINGS AND FOR OTHER PURPOSES.**

**WHEREAS**, Ordinance No. 22-690 was enacted on June 22, 2022, amending certain provisions of the Revenue Code of Isabela City to establish new economic enterprises and prescribe fees and charges;

**WHEREAS**, there is a need to specify the fees and charges for the lease of office spaces at the second floor of the newly established economic enterprise known as the Cyberzone building and in all government owned buildings classified for lease spaces for offices.

**NOW, THEREFORE, BE IT ORDAINED** by the Sangguniang Panlungsod of Isabela City, that:

**SECTION 1.** Section 1 of Ordinance No. 22-690 is hereby further amended to include the following provision:

- A. The fees and charges for the lease of office spaces shall be set at Twenty-Five (P25.00) pesos per square meter.

**SECTION 2.** All other provisions of Ordinance No. 22-690 shall remain in full force and effect.

**SECTION 3. Effectivity.** This ordinance shall take effect immediately upon its approval.
