**AN ORDINANCE APPROVING THE ANNUAL EXECUTIVE GENERAL FUND BUDGET FOR CALENDAR YEAR 2025 OF THE CITY GOVERNMENT OF ISABELA, PROVINCE OF BASILAN, IN THE AMOUNT OF ONE BILLION ONE HUNDRED SIXTY-ONE MILLION ONE HUNDRED THIRTY-TWO THOUSAND NINE HUNDRED SEVENTY-TWO PESOS AND FIFTY-NINE (P1,161,132,972.59) CENTAVOS.**
