A RESOLUTION CONCURRING THE BARANGAY ANNUAL BUDGET OF BARANGAY PORT AREA, THIS CITY, FOR CALENDAR YEAR 2024.

WHEREAS, Sections 333(a), of Republic Act 7160, otherwise known as the Local Government Code of 1991, states that, *“Within ten (10) days from its approval, copies of the barangay ordinance authorizing the annual appropriations shall be furnished the Sangguniang Panlungsod x x x as the case may be, through the City Budget Officer. The Sanggunian concerned shall have the power to review such ordinance in order to ensure that its provisions are complied with”;*

WHEREAS, the Barangay Annual Budget for Calendar Year 2024 for Port Area Barangay, was forwarded to the Hon. Presiding Officer and Members, through the SP Secretary, as embodied in the appropriation Ordinance No. 1 series of 2023, in the amount of Three Million One Hundred Thirty Six Thousand Four Hundred Forty Nine (P 3,136,449.00) Pesos;



WHEREAS, the said Barangay Budget shows substantial compliance with the provisions of the code on the preliminary review conducted by the Office of the City Budget;


NOW, WHEREFORE, upon motion of Councilor Khaleedsher M. Asarul, duly seconded by members present;
