AN ORDINANCE REALIGNING THE AMOUNT OF FIVE MILLION FORTY-ONE THOUSAND TWO HUNDRED NINETY-TWO PESOS AND THIRTEEN CENTAVOS (P5,041,292.13) PESOS, TAKEN FROM THE REMAINING BALANCE UNDER THE TERMINAL LEAVE BENEFITS, OFFICE OF THE SANGGUNIANG PANLUNGSOD, BE REALIGNED AND RE-APPROPRIATED TO AUGMENT THE PRESENT APPROPRIATION FOR FUEL AND OIL AND OTHER MAINTENANCE AND OPERATING EXPENSES OF THE SAME OFFICE, THIS CITY.


After due deliberation on the matter, upon motion of Councilor James Abner S. Rodriguez, duly seconded by members present,

NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Panlungsod of Isabela City, that:


SECTION 1. The amount of five million forty-one thousand two hundred ninety-two pesos and thirteen centavos (P5,041,292.13) taken from the remaining balance under the Terminal Leave Benefits, Office of The Sangguniang Panlungsod, this City, be realigned and re-appropriated to augment the present appropriation for Fuel and Oil in the amount of two million four hundred thousand pesos (P2,400,000.00), and Other Maintenance and Operating Expenses, in the amount of two million six hundred forty-one thousand two hundred ninety-two pesos and thirteen centavos (P2,641,292.13), of the same Office.


SECTION 2. EFFECTIVITY. This Ordinance shall take effect upon its approval.
