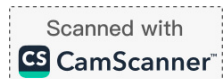

A RESOLUTION CONCURRING AND ADOPTING CITY DEVELOPMENT COUNCIL (CDC) RESOLUTION NO. 01, S.2025, APPROVING THE PROPOSED REALIGNMENT OF FUNDS UNDER 20% DEVELOPMENT FUND FOR CALENDAR YEAR 2024 IN THE AMOUNT OF FIVE MILLION AND FIVE HUNDRED THOUSAND PESOS (P5,500,000.00) FOR THE CONSTRUCTION OF CONCRETE FOOTBRIDGE AND DOCKING AREA AT FUEGO-FUEGO, BARANGAY TABIAWAN, AMOUNTING THREE MILLION PESOS (P3,000,000.00) AND THE IMPROVEMENT OF BARANGAY HALL AT BARANGAY KAUMPURNAH ZONE 1, THIS CITY, AMOUNTING TWO MILLION AND FIVE HUNDRED THOUSAND PESOS (P2,500,000.00), TO BE INCLUDED IN THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM CALENDAR YEAR 2025.

WHEREAS, Sec. 16, of the Local Government Code of 1991, provides th,at every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare.

WHEREAS, the City Government of Isabela acquired savings from the 20% Development Fund, in the amount of Five Million Five Hundred Thousand Pesos (P5,500,000.00), be realigned to the proposed Footbridge and Docking Area Project at Fuego-Fuego, Barangay Tabiawan and the improvement project of the Barangay Hall at Barangay Kaumpurnah Zone 1, Isabela City, Basilan.



WHEREAS, City Development Council Resolution No. 1, series of 2025, approves the realignment of savings from the 20% Development Fund, for CY 2024, in the amount Five Million and Five Hundred Thousand Pesos (P5,500,000.00).


NOW, WHEREFORE, upon motion of Councilor James Abner S. Rodriguez, duly seconded by Councilor Bimbo E. Epping.
