A RESOLUTION GRANTING AUTHORITY TO MAYOR SITTI DJALIA A. TURABIN-HATAMAN, THIS CITY, TO ENTER INTO A TRIPARTITE MEMORANDUM OF AGREEMENT (TMOA) BY AND AMONG THE CITY GOVERNMENT OF ISABELA, BASILAN PROVINCE, THE DEPARTMENT OF TOURISM (DOT), AND THE TOURISM INFRASTRUCTURE AND ENTERPRISE ZONE AUTHORITY (TIEZA), IN THE IMPLEMENTATION OF THE LAMPINIGAN SUSTAINABLE AND NATURAL DESTINATION OF THE SOUTH: THE JETTY PORT AND LEISURE DEVELOPMENT PROJECT.

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that, *"Every Local Government Unit shall exercise the powers expressly granted, those necessarily implied therefrom as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare"*;

WHEREAS, The Department of Tourism (DOT) is the primary planning, programing, coordinating, implementing and regulatory government agency in the development and promotion of the tourism industry;

WHEREAS, The Tourism Infrastructure and Enterprise Zone Authority (TIEZA), was mandated to develop, manage, and supervise tourism infrastructure projects in the Country;

WHEREAS, The City Government of Isabela, Province of Basilan, shall operate and the manage the Lampinigan SANDS such as but not limited to the pasalubong center and jetty port that will showcase locally-made products and maintain and conserve its condition with utmost care and diligence.


NOW, WHEREFORE, upon motion of Councilor Jeromy L. Casas, duly seconded by members present.


