RESOLUTION REQUESTING THE POLICE REGIONAL OFFICE 9 TO ASSIGN POLICE PERSONNEL RECOMMENDED BY THE AD HOC BODY OF THE CITY GOVERNMENT OF ISABELA CHAIRED BY MAYOR SITTI DJALIA TURABIN-HATAMAN, TO THE ISABELA CITY POLICE STATION.

WHEREAS, the Isabela City Police Station is currently understaffed based on the national standard ratio of 1 police officer to 500 residents;

WHEREAS, the current ratio of police officers to residents in Isabela City is 1:800, indicating a significant shortage of personnel to effectively maintain law and order;

WHEREAS, an ad hoc resolution was previously passed recommending the enlistment of the following police personnel who were all are residents of Isabela City:


