A RESOLUTION GRANTING AUTHORITY TO MAYOR SITTI DJALIA A. TURABIN-HATAMAN, THIS CITY, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN THE CITY GOVERNMENT OF ISABELA, BASILAN PROVINCE AND THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD), FOR THE IMPLEMENTATION OF THE YAKAP BAYAN PROGRAM OF DSWD.

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that, *"Every Local Government Unit shall exercise the powers expressly granted, those necessarily implied therefrom as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare"*;

WHEREAS, the Yakap Bayan Program of the DSWD, is an intervention to assist recovering persons who used drugs and facilitate their social integration, providing counselling sessions, health and fitness therapy, spiritual interventions, skills training, and capacity-building;

WHEREAS, the DSWD formulated the Yakap Bayan Framework of Intervention for a strategic and coordinated provision of services to Recovering Person Who Used Drugs (RPFUDs) which will converge readily available resources from the national government agencies, civil society organizations, and faith-based organizations;

WHEREAS, the Local Government Unit of Isabela City, Province of Basilan, shall enact legislations that will support the implementation and sustainability of the program and providing funds thereof and same shall be included in the Annual Investment Plan.


