**A RESOLUTION GRANTING AUTHORITY TO MAYOR SITTI DJALIA A. TURABIN-HATAMAN, THIS CITY, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN THE CITY GOVERNMENT OF ISABELA, BASILAN PROVINCE AND THE NATIONAL AUTHORITY FOR CHILD CARE (NACC), FOR THE IMPLEMENTATION AND SUPPORT TO THE PHILIPPINE FOSTER CARE PROGRAM.**

**WHEREAS**, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that, *“Every Local Government Unit shall exercise the powers expressly granted, those necessarily implied therefrom as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”;*

**WHEREAS**, the National Authority for Child Care (NACC), is mandated to provide alternative parental care, protection and assistance to every child who is surrendered, orphaned, abandoned, neglected, or dependent through adoption and/or foster care;

**WHEREAS**, the local government unit is mandated to promote the foster care system and support the Philippine Foster Care Program of the NACC to ensure the optimum growth, rehabilitation, and development of children placed under foster care.

**NOW, WHEREFORE**, upon motion of Councilor Karel Annjaiza R. Sakkalahul, duly seconded by members present.

**BE IT RESOLVED**, that the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, grants authority to Mayor Sitti Djalia A. Turabin-Hataman, this City, to enter into a Memorandum of Agreement (MOA) by and between the City Government of Isabela, Basilan Province and the National Authority for Child Care (NACC), for the implementation and support to the Philippine Foster Care Program.


