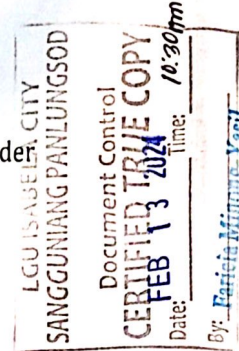

A RESOLUTION CONCURRING THE ANNUAL GENERAL FUND BUDGET OF BARANGAYS DIKI, BEGANG, MARKETSITE, AND KUMALARANG FOR CALENDAR YEAR 2025.

WHEREAS, Sections 333(a), of Republic Act 7160, otherwise known as the Local Government Code of 1991, states that *"Within ten (10) days from its approval, copies of the barangay ordinance authorizing the annual appropriations shall be furnished the Sangguniang Panlungsod x x x, through the City Budget Officer. The Sanggunian concerned shall have the power to review such ordinance in order to ensure that its provisions are complied with";*
