A RESOLUTION REQUESTING THE PUNONG BARANGAYS OF DIKI, DOÑA RAMONA, TABUK, BUSAY, AND SMALL KAPATAGAN, TO SUBMIT MINUTES OF THE PUBLIC HEARINGS AND CONSULTATIONS WITH CORRESPONDING ATTENDANCE SHEETS, AND OTHER PERTINENT DOCUMENTS THAT WILL SUPPORT THE ENACTMENT OF THEIR REVISED BARANGAY TAX CODES.

WHEREAS, Section 458 (1i), of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that, *"The Sangguniang Panlungsod shall review all ordinances approved by the sangguniang barangay and executive orders issued by the punong barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and of punong barangay"*;

WHEREAS, Section 187, of Republic Act 7160, otherwise known as the Local Government Code of 1991, states that, *"The procedure for approval of local tax ordinances and revenue measures shall be in accordance with the provisions of this Code, provided that public hearings shall be conducted for the purpose prior to the enactment thereof"*;
