A RESOLUTION GRANTING AUTHORITY TO HONORABLE SITTI DJALIA TURABIN HATAMAN, MAYOR, THIS CITY, TO PURCHASE ONE (1) UNIT UTILITY VEHICLE INTENDED FOR THE PHILIPPINE COAST GUARD-ISABELA CITY STATION, AS INDICATED IN THE POPS PLAN 2025, UNDER ANNUAL INVESTMENT PLAN (AIP) .

WHEREAS, Section 16, of Republic Act No. 7160, otherwise known as the Local Government Cod of 1991, provides that, every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, xxx maintain peace and order xxx, and preserve the comfort and convenient of their inhabitants;

WHERAS, the Peace, Order and Public Safety Plan 2025, provides for the procurement of one unit utility vehicle to be used for land mobility and law enforcement operations of the Philippine Coast Guard-Isabela City station amounting to Nine Hundred Fifty Thousand (P950,000.00) Pesos;


NOW, THEREFORE, upon motion of Councilor James Abner S. Rodriguez, duly seconded by members present,
