A RESOLUTION GRANTING AUTHORITY TO MAYOR SITTI DJALIA A. TURABIN HATAMAN, THIS CITY, TO ENTER INTO A TRIPARTITE MEMORANDUM OF AGREEMENT (TMOA), BY AND AMONG THE CITY GOVERNMENT OF ISABELA, THE PHILIPPINE COFFEE BOARD INC., AND THE ISABELA CITY COFFEE GROWERS ASSOCIATION, TO PROVIDE SUSTAINABLE INCOME OPPORTUNITIES FOR ISABELA CITY FARMERS.

WHEREAS, Section 455 (b1)(vi), of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides, that *"The City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contract, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;*

WHEREAS, the Isabela City Coffee Growers Association (ICCGA) is a non-profit, non-stock association engaged in assisting coffee-farming communities in the City of Isabela, Province of Basilan;

WHEREAS, the Philippine Coffee Board (PCB), Inc., has been advocating coffee-based agro-forestry or small holder coffee groves as a strategy to improve competitiveness of the country in the global coffee market;

WHEREAS, the City Government of Isabela through the City Agriculture Office, supports coffee farming and cultivation, providing sustainable income opportunities for farmers and developing the coffee industry in the City;


NOW, THEREFORE, upon motion of Councilor Candu I. Muarip, duly seconded by members present,


