A RESOLUTION GRANTING AUTHORITY TO MAYOR SITTI DJALIA A. TURABIN-HATAMAN, THIS CITY, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN THE CITY GOVERNMENT OF ISABELA AND THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) IN THE IMPLEMENTATION OF THE 15TH CYCLE SUPPLEMENTARY FEEDING PROGRAM OF THE DSWD.

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that, *“Every Local Government Unit shall exercise the powers expressly granted, those necessarily implied therefrom as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”*;

WHEREAS, the Supplementary Feeding Program (SFP) of the Department of Social Welfare and Development provides food in addition to the regular meals to children ages 2-5 enrolled in Child Development Centers and Supervised Neighborhood Plays (SNPs);

WHEREAS, the Local Government Unit of Isabela, will enact programs on child and youth welfare and the rights of children to survival, development and special protection with full recognition of the nature of childhood.


NOW, WHEREFORE, upon motion of Councilor James Abner S. Rodriguez, duly seconded by members present,


