**A RESOLUTION FORWARDING TO THE NATIONAL COMMISSION ON MUSLIM FILIPINOS (NCMF), A REQUEST FOR APPROPRIATE ACTION REGARDING THE ALLEGED HAJJ SCAM INVOLVING AL-HARAMAIN TRAVEL AND TOURS.**

**WHEREAS**, Al-Haramain Travel and Tours has been implicated in fraudulent Hajj activities, with reports indicating the collection of substantial funds from pilgrims without the requisite accreditation to operate for Hajj 2025;

**WHEREAS**, the above-mentioned travel and tours is currently facing accusations of stranding pilgrims due to outstanding fees and failure to secure necessary visas;

**WHEREAS**, the National Commission on Muslim Filipinos (NCMF)-Bureau of Pilgrimage and Endowment said that Al-Haramain Travel and Tours was not included in the 2025 Hajj Accredited Travel Agency list, as disseminated via Hajj Advisory BPE No 2025-018 on March 13, 2025;
