**A RESOLUTION REQUESTING ALL SHIPPING LINES PLYING THE ROUTE OF ISABELA-ZAMBOANGA AND VICE-VERSA FOR AN ADDITIONAL TRIP.**

**WHEREAS**, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that, *“Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare xxx promote health and safety, and preserve the comfort and convenience of the inhabitants”;*

**WHEREAS**, Aleson Shipping Lines, Montenegro Shipping Lines, and Weesam Express were among the shipping lines plying the Isabela-Zamboanga vice-versa sea route;

**WHEREAS**, travel by sea is the only mode of transport for most of the people of Basilan, particularly Isabela City being from an island province;

**WHEREAS**, with the growing population and needs of the constituents of Isabela City, government agencies are now extending satellite offices in the province thereby assigning employees who are residents of Zamboanga City;
