WHEREAS, the Development Bank of the Philippines (DBP) is the depository bank of the City Government of Isabela providing salary servicing, ATM servicing, and salary loan program for the city government employees;

WHEREAS, the City Government of Isabela through the City Mayor, has entered into an agreement with DBP for the aforementioned services which is now subject for renewal.


NOW, WHEREFORE, upon motion of Councilor James Abner S. Rodriguez, duly seconded by members present,
