WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that, *“Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”*;


WHEREAS, The Barangay can contribute significantly to reducing traffic congestion and improving the overall traffic flow within its jurisdiction;

WHEREAS, It has been observed that during peak hours, barangays Riverside, Dona Ramona, and Seaside are prone to congestion, leading to slow mobility of commuters;

WHEREAS, Cooperation among the aforementioned barangays is necessary to mitigate heavy traffic and reduce the risk of accidents;


NOW, WHEREFORE, upon motion of Councilor Khaleedsher M. Asarul, duly seconded by members present,


