A RESOLUTION DESIGNATING/RENAMING THE RURAL HEALTH UNIT (RHU) I AMBULANCE TO ISABELA SUPER HEALTH CENTER AMBULANCE UNIT, AS RECOMMENDED BY THE LOCAL HEALTH BOARD (LHB) OF ISABELA CITY.

WHEREAS, on July 23, 2025, the Isabela Local Health Board (LHB) convened its Second Quarterly Meeting, and adopted a decision requesting the Sangguniang Panlungsod designating/renaming the RHU I Ambulance Unit under the RHU I East to Isabela Super Health Center Ambulance Unit, a requisite in licensing and accreditation from the Department of Health (DOH);

WHEREAS, the ambulance unit amounting to Two Million Seventy-Five Thousand Pesos (P2,075,000.00), was donated to the City of Isabela through the Health Facilities Enhancement Program (HFEP) of the DOH, Fiscal Year 2022 through a Deed of Donation entered into by the DOH and the City of Isabela on September, 2023;

WHEREAS, the ambulance unit with Official Receipt No. 2306163403, and Certificate of Registration (CR) No. 47572469-0 remains free-standing or operational, however, is not licensed nor accredited by the DOH;

WHEREAS, the DOH licensing is a step forward in guaranteeing the standards for public safety and quality care;

WHEREAS, in the interest of pursuing DOH licensing and accreditation of the said ambulance, there is need to designate/rename the unit to Isabela Super Health Center Ambulance Unit, consistent with its Deed of Donation;

WHEREAS, the designation of the unit through Resolution No. 24-7002, duly approved by the Sangguniang Panlungsod on October 24, 2024 under the RHU I Ambulance Unit was found necessary in place of Isabela Super Health Center, as the latter was not yet operational at that time.

NOW, WHEREFORE, upon motion of Councilor Asan Al-Ameen S. Camlian, duly seconded by members present,

BE IT RESOLVED, that the Sangguniang Panlungsod of Isabela, Province of Basilan, designates/renames the Rural Health Unit (RHU) I Ambulance to Isabela Super Health Center Ambulance Unit, as recommended by the Local Health Board (LHB) of Isabela City.


RESOLVED FURTHER, that the designation of the Isabela Super Health Center Ambulance Unit is properly reflected in the books of assets, and other related records of the City Government.


