CREATION OF THE COMPOSITE VALIDATION AND ASSESSMENT TASK TEAM (CVATT) FOR THE BARANGAY ROAD CLEARING PROGRAM IN THE CITY OF ISABELA, PROVINCE OF BASILAN

WHEREAS, the road clearing of roads aims to remove obstruction and illegal constructions that could help motorists to drive better, and for pedestrians to find safe areas to walk on. Further, the road clearing program also design to reclaim streets, alleys and walkways so that pedestrians will be encouraged to walk thereby promoting mobility and a healthy lifestyle;

WHEREAS, the DILG has issued various policies on road clearing operation such as DILG MC No. 2019-167 dated July 29, 2019, DILG MC No. 2019-167 dated October 04, 2019, DILG MC No. 2020-027 dated February 07, 2020, DILG MC No. 2020-145 dated October 27, 2020, DILF MC No. 2020-085 dated June 20, 2022, MC No. 2023-017 dated January 25, 2023, and the latest of which is Memorandum Circular No. 2024-053 dated April 16, 2024;

WHEREAS, the *aforecited* circulars direct all Local Government Units (LGUs) to conduct road cleaning operations and for barangays to implement the Barangay Road Clearing Operations (BaRCO), and undertake other initiatives to reclaim public roads which are being used for private ends, and to clear and maintain barangay roads, streets, alleys sidewalks, including those cleared roads that were turned over to the barangay government;

WHEREAS, Memorandum Circular No. 2024-053 dated April 16, 2024 also mandates for the creation of a Composite Validation and Assessment Task Team (CVATT);

NOW THEREFORE, I, SITTI DJALIA A. TURABIN - HATAMAN, City Mayor of Isabela City, Province of Basilan, by virtue of the power vested in me by law, do hereby **ORDER**:

Section 1. Composite Validation and Assessment Task Team (CVATT).

As provided under Item 5.3.2 of DILG MC No. 2024-053, the composition of the CVATT for the City of Isabela shall be the following:

Section 2. CVATT Duties and Responsibilities.

- a) Conduct meetings and consultations to baranagays officials and other stakeholders in relation to the implementation of the Barangay Road Clearing Operations (BaRCO).
- b) Check and gauge barangay compliance with the national government's directive and policies of the DILG related to the conduct of Barangay Road Clearing Operations (BaRCO).
- c) Conduct Quarterly BaRCO Validation and assessment in partnership with the City Government of Isabela.

Section 3. TTF Secretariat

The DILG and the BAGO Office shall provide secretariat support to the CVATT.

Section 4. Funding Support.
