AN ORDINANCE REALIGNING THE AMOUNT OF THREE MILLION TWO HUNDRED FIFTY THOUSAND (P3,250,000.00) PESOS, TAKEN FROM THE APPROPRIATION FOR THE CONSTRUCTION OF FOOTBRIDGE AT TAMPALAN ELEMENTARY SCHOOL, TAMPALAN BARANGAY, AND SAME BE REALIGNED FOR THE CONSTRUCTION OF CONCRETE FOOTBRIDGE AT TAMPALAN ELEMENTARY SCHOOL, CARBON BARANGAY, THIS CITY.

WHEREAS, Resolution No. 13, 2024, of the Executive Committee, City Development Council, was approved on September 27, 2024, amending the title of the proposed project from Construction of Concrete Footbridge at Tampalan Elementary School, Barangay Tampalan to Construction of Concrete Footbridge at Tampalan Elementary School, Barangay Carbon;

WHEREAS, Resolution No. 13, 2024, also approved the amendment of the project cost from P3,500,000.00 to P3,250,000.00.

NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Panlungsod of Isabela City, that:

The Amount of Three Million Two Hundred Fifty Thousand Pesos (P3,250,000.00), taken from the appropriation for the construction of a concrete footbridge at Tampalan Elementary School, Barangay Tampalan, be realigned and re-appropriated for the construction of a concrete footbridge at Tampalan Elementary School, Barangay Carbon.
