AN ORDINANCE REALIGNING THE AMOUNT OF FIVE MILLION FIVE HUNDRED THOUSAND PESOS (P5,500,000.00) TAKEN FROM THE 20% DEVELOPMENT FUND FOR CALENDAR YEAR 2024 FOR THE CONSTRUCTION OF CONCRETE FOOTBRIDGE AND DOCKING AREA AT TABIAWAN BARANGAY, AND RE-APPROPRIATING THE SAME FOR THE CONSTRUCTION OF FOOTBRIDGE AT FUEGO-FUEGO, TABIAWAN BARANGAY IN THE AMOUNT OF THREE MILLION PESOS (P3,000,000.00) AND IMPROVEMENT OF BARANGAY HALL AT KAUMPURNAH ZONE I, IN THE AMOUNT OF TWO MILLION FIVE HUNDRED THOUSAND PESOS, ALL OF THIS CITY AND TO BE INCLUDED IN THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM FOR CALENDAR YEAR 2025.

NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Panlungsod of Isabela City, that:

SECTION 1. The amount of Five Million Five Hundred Thousand Pesos (P5,500,000.00) taken from the 20% Development Fund for CY 2024 for the construction of concrete footbridge and docking area at Tabiawan Barangay, be re-aligned and re-appropriated for the construction of footbridge at Fuego-Fuego, Tabiawan Barangay in the amount of Three Million Pesos (P3,000,000.00) and improvement of barangay hall at Kaumpurnah Zone I, in the amount of Two Million Five Hundred Thousand Pesos (P2,500,000.00), all of this City.



SECTION 3. Effectivity. This ordinance shall take effect immediately upon its approval.


