AN ORDINANCE REALIGNING THE AMOUNT OF ONE HUNDRED FORTY THOUSAND (P140,000.00) PESOS, TAKEN FROM THE APPROVED PEACE AND ORDER AND PUBLIC SAFETY (POPS) PLAN 2023, AS INTEGRATED IN THE ANNUAL INVESTMENT PLAN (AIP) FOR THE PROCUREMENT AND INSTALLATION OF CLOSE-CIRCUITS TELEVISIONS (CCTV's), BE REALIGNED FOR THE PROCUREMENT OF CCTV MONITORS AND EQUIPMENT.

After due deliberation on the matter, upon motion of Councilor James Abner S. Rodriguez, duly seconded by members present;

BE IT ORDAINED by the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, **THAT:**

SECTION 1. The amount of **ONE HUNDRED FORTY THOUSAND (P140,000.00) PESOS**, taken from the approved POPS Plan 2023 as integrated in the Annual Investment Plan (AIP), intended for the procurement and installation of CCTV units, be realigned for the procurement of CCTV monitors and equipment allocated for the Bureau of Jail Management and Penology (BJMP).
