A RESOLUTION GRANTING AUTHORITY TO MAYOR SITTI DJALIA A. TURABIN HATAMAN, THIS CITY, TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU), BY AND BETWEEN THE CITY GOVERNMENT OF ISABELA AND THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT, IN THE IMPLEMENTATION OF THE SOCIAL PENSION FOR INDIGENT SENIOR CITIZENS PROGRAM OF DSWD.

WHEREAS, Section 455(b)(1vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that, *"The Chief Executive shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance"*;

WHEREAS, the Department of Social Welfare and Development (DSWD) as the lead agency in promoting the wellness of the constituents has implemented the Social Pension for Indigent Senior Citizens (SPISC) since 2011;

WHEREAS, the local government unit shall mobilize the Senior Citizen Organizations and Barangay Officials to assist in the information dissemination on the schedule of the Social Pension Pay-out and in the grievances of its members.


NOW, WHEREFORE, upon motion of Councilor Candu I. Muarip, duly seconded by members present,

BE IT RESOLVED, that the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, grants authority to Mayor Sitti Djalila A. Turabin Hataman, this City, to enter into a Memorandum of Agreement (MOA), by and between the City Government of Isabela and the Department of Social Welfare and Development, in the implementation of the Social Pension For Indigent Senior Citizens Program of DSWD.
