A RESOLUTION GRANTING AUTHORITY TO MAYOR SITTI DJALIA A. TURABIN-HATAMAN, THIS CITY, TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) BY AND BETWEEN THE CITY GOVERNMENT OF ISABELA, BASILAN PROVINCE, AND THE GLOBE TELECOM INC., FOR THE ERECTION OF SIGNAL POLES AND INSTALLATION OF SIGNAL BOOSTER IN THE CITY.

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that, *“Every Local Government Unit shall exercise the powers expressly granted, those necessarily implied therefrom as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”*;

WHEREAS, the GLOBE Telecom Inc., will be erecting poles and installing signal booster at Kaumpurnah Barangay, Isabela City, which will provide better internet connection and improved telecommunication services in the City;



WHEREAS, the completion of the proposed project will improve the voice and data services provided by GLOBE Telecom in the Island Province of Basilan, particularly Isabela City;


NOW, WHEREFORE, upon motion of Councilor James Abner S. Rodriguez, duly seconded by all members present,

BE IT RESOLVED, that the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, grants authority to Mayor Sitti Djalía A. Turabin-Hataman, this City, to enter into a Memorandum of Understanding (MOU) by and between the City Government of Isabela, Basilan Province, and the GLOBE Telecom Inc., for the erection of signal poles and installation of signal booster in the City.
