**A RESOLUTION GRANTING AUTHORITY TO MAYOR SITTI DJALIA A. TURABIN-HATAMAN, THIS CITY, TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) BY AND BETWEEN THE CITY GOVERNMENT OF ISABELA, BASILAN PROVINCE, AND THE MARITIME INDUSTRY AUTHORITY (MARINA) REGION IX, IN THE IMPLEMENTATION OF AN EFFECTIVE AND EFFICIENT MARITIME ADMINISTRATION GOVERNANCE SYSTEM, IN THE CITY.**

**WHEREAS**, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that, *“Every Local Government Unit shall exercise the powers expressly granted, those necessarily implied therefrom as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”;*

**WHEREAS**, the MARINA through its Maritime Safety Culture Awareness Campaign Caravan, as mandated in the Maritime Industry Development Plan for 2019-2028, shall ensure the enhancement of maritime transport safety and security, and shall promote environmentally sustainable maritime industry in the City;



**WHEREAS**, the City Government of Isabela, Basilan Province, through the Maritime Safety Culture Awareness Campaign Caravan, shall take an active role in the raise of public awareness on maritime safety and standards in the City.


**NOW, WHEREFORE**, upon motion of Councilor James Abner S. Rodriguez, duly seconded by all members present,
