A RESOLUTION GRANTING AUTHORITY TO MAYOR SITTI DJALIA A. TURABIN-HATAMAN , THIS CITY, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA), BY AND AMONG THE CITY GOVERNMENT OF ISABELA, CLARET COLLEGE OF ISABELA, INC., CALVARIO PEAK NATIONAL HIGH SCHOOL, AND THE QORBAN INSTITUTE OF TECHNOLOGY TRAINING AND ASSESSMENT CENTER, INC., IN THE IMPLEMENTATION OF THE WORK IMMERSION PROGRAM OF THE DEPARTMENT OF EDUCATION.

WHEREAS, Department of Education Order No. 30, series of 2017, provides for the Guidelines for Work Immersion as basis for the implementation of work immersion being the key subject in all Senior High Schools (SHSs) curriculum, which aims to develop the competencies, work ethic, and values of learners relevant to pursuing further education or joining the workforce;

WHEREAS, the City Government of Isabela, Basilan Province, will provide ground for learning to all graduating senior high school students by undergoing work immersion which will provide them actual experiences in the workforce;

WHEREAS, the Department of Education through its K to 12 basic education reform program will ensure that graduates will be provided the necessary expertise and venue for practical on-the-job training.

NOW, WHEREFORE, upon motion of Councilor James Abner S. Rodriguez, duly seconded by all members present,

BE IT RESOLVED, that the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, grants authority to Mayor Sitti Djalía A. Turabin-Hataman, this City, to enter into a Memorandum of Agreement (MOA), by and among the City Government of Isabela, Claret College of Isabela, Inc., Calvario Peak National High School, and the Qorban Institute of Technology Training and Assessment Center, Inc., in the implementation of the Work Immersion Program of the Department of Education.


