**A RESOLUTION GRANTING AUTHORITY TO MAYOR SITTI DJALIA A. TURABIN-HATAMAN, THIS CITY, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN THE CITY GOVERNMENT OF ISABELA, BASILAN PROVINCE, AND THE NATIONAL COMMISSION FOR CULTURE AND THE ARTS, IN THE IMPLEMENTATION OF THE HAPISABELA AWARD FOR BUILDERS OF ISABELA DE BASILAN, ISABELA CITY, BASILAN PROVINCE.**

**WHEREAS**, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that, *“Every Local Government Unit shall exercise the powers expressly granted, those necessarily implied therefrom as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;”*

**WHEREAS**, Republic Act No 7356, provides that, *“The National Commission for Culture and the Arts (NCCA), shall encourage the continuing balanced development of a pluralistic culture by the people, conserve and promote the nation’s cultural heritage, ensure the widest dissemination of artistic and cultural products and preserve and integrate traditional culture and its various creative expressions as a dynamic part of the national cultural mainstream;”*



**WHEREAS**, the HAPIsabela Award for Builders of Isabela de Basilan Project, acknowledges the invaluable contributions of local artists who dedicated themselves to preserving and promoting intricate and culturally significant tangible and intangible cultural traditions which will encourage future generations to uphold and value their heritage.


**NOW, WHEREFORE**, upon motion of Councilor Mary May B. Julhari, duly seconded by members present,

**BE IT RESOLVED**, that the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, grants authority to Mayor Sitti Djalía A.
