A RESOLUTION GRANTING AUTHORITY TO MAYOR SITTI DJALIA A. TURABIN-HATAMAN, THIS CITY, TO PURCHASE ONE (1) UNIT DISASTER RESCUE VEHICLE (AMBULANCE BOX TYPE), FOR EMERGENCY AND DISASTER RESPONSE OPERATION IN THE CITY.

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that, *“Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;”*

WHEREAS, the City Government of Isabela on its quest to enhance emergency response capabilities needs disaster rescue vehicles capable of handling all types of terrain;

WHEREAS, the proposed budget for the purchase of a 4x4 rescue vehicle with emergency equipment and apparatus (ambulance box type) amounts to five million pesos (P5,000,000.00), and will be used by the City Government in responding to emergencies and disasters.


NOW, WHEREFORE, upon motion of Councilor James Abner S. Rodriguez, duly seconded by members present,
